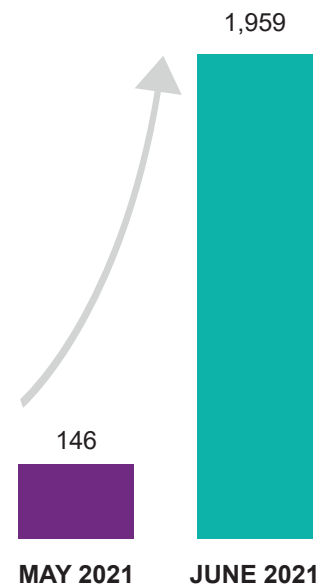
## The Results
